- While allotting seats University authorities will verify each and every document during counselling process. Hence, the eligibility will be decided by the University as per the norms laid down in the Government Order.

Note:
The following clauses shall be considered in the course of NCC admissions in respect of Go. Ms. No: 14 dated: 09-06-2017 of Higher Education (TE) Department.

- Priority will be Considered in C, B & A Certificates attained prior to appearing in the qualifying examination i.e., Intermediate / +2 Examination for TSEAPCET Admissions.
- The NCC Directorate, Telangana & Andhra Pradesh shall be responsible to draw the merit list in respect of the NCC Cadets seeking admission under NCC Category for all the candidates.
- In case of a tie, TSCET merit will be the deciding factor for the position in the merit list under NCC category.
- Only NCC Certificates issued by NCC authorities shall be valid.
- The above priorities will be given to the Certificates acquired if the candidates represent through NCC only and the same has to be endorsed on the Certificate.

- *Any cancellation/withdrawal of admissions after the closure of the admission process, the candidate shall forfeit the entire fees (except the caution deposits). In addition, the candidate has to pay Rs. 2,000/- (@ Rs. 10,000/- for Special quota) as processing fee.*

- TG-EAPCET-2025 Rank card.
- Bonafide / Study Certificate from VI to XII class.
- The latest certified copy of the social status (caste), certificate issued by the competent authority from Telangana in case of applicants belonging to Backward classes, Scheduled caste and Scheduled tribes.
- The latest certified copy of the EWS certificate issued for the year 2025-26 by the competent authority from TS state in case of applicants belonging to EWS.
- National Cadet Corps (NCC) Certificate.

Important Instructions:

- All the candidates who have verified under NCC quota with TG EAPCET-2025 Rank as per the notification of the University are eligible to attend the counselling.
- The officers of Directorate of NCC, Telangana are verified the original NCC certificates of the candidates.
- The candidates are required to bring TWO sets of online application with all enclosures along with original certificates for verification.
- Seats shall be filled up as per ranks obtained in the Telangana EAPCET-2025 and duly following the rule of reservation as and when the priorities are indicated by the officers of Directorate of NCC, Telangana.
- **Open Competition (OC) means the candidate belonging to OC, EWS, BC, SC and ST.**
- **The guidelines issued by Government of Telangana from time to time shall be followed scrupulously.**
- In the event of establishment of new colleges or any other administrative decisions, such seats will also be considered for filling up through this notification only.

- Candidates called for counselling will have to attend at their own cost and only one parent / guardian of the candidate will be allowed to accompany the candidate during the counselling process.
- **More number of candidates than the availability of seats are called for counselling and hence, mere attendance / participation during counselling does not guarantee admission.**
- **In case, the information furnished or the certificates uploaded by the candidates are found to be false, the University will take appropriate action against the individuals concerned.**
- The University is not responsible for any information provided in websites other than at www.pjtau.edu.in.
- **Parents and Students are informed that the admissions are purely based on merit and guidelines of the University and as such they are requested not to rely on any middlemen/persons/consultants who try to mislead the students in securing admission into PJTAU under any quota.
