**GUIDELINES FOR
MANDAVA VENKATRAMAIAH AWARD FOR BEST TEACHER / RESEARCH SCIENTIST
(SPONSORED BY MANDAVA FOUNDATION)**

1. Teachers / Scientists in the cadre of Assistant Professor/Associate Professor will be eligible for the Award.
2. Minimum of 5 years of Research/ Teaching experience at any research station/ College is necessary to become eligible for the award
3. The total number of awards may be 2 (One each for Teaching and Research)
4. The awards may be given every year
5. Any or All the awards will not be given in a particular year if suitable researcher / teacher are not available. The awards will also lapse and will not be carried to subsequent Years
6. Each award consist of cash, Citation and a memento .
- 7. Procedure for selection:**
 - i) The application may be submitted by the Research Scientist / Teachers themselves through their Heads of Office / ADRs/ ADs (four sets).
 - ii) A committee consisting of the Associate Director of Research / Associate Deans with 2 senior Officers may be constituted to screen the applications received .All the applications received along with recommended list of candidates by the Committee may be forwarded to the University.
 - 1 A committee appointed by the Vice- Chancellor may evaluate the applications/Nominations received from Associate Directors of Research/Associate Deans keeping in view the weightage as mentioned above and send their recommendations to the Vice – Chancellor for consideration and approval
 - 2 There should be atleast 5 years of gap between two awards for the same teacher / scientist
 - 3 The University reserves the right to select or not any applicant.
