# ANNEXURE – I

## GUIDELINES FOR SRI MOCHERLA DATTATREYULU CENTENARY AWARD

#### **Description of the Award**

The family members of Sri Mocherla Dattatreyulu, former faculty member of this University, have instituted an award in the name of Sri Mocherla Dattatreyulu to be awarded to the best Scientist / Economist / Banker during the PJTSAU Foundation Day.

- The Award consists of a Gold medal, Cash prize of Rs.25,000/- and Citation.
- The Award is given annually.
- If no candidate is found suitable for the award, the announcement of award shall stand cancelled for the notified period.
- The university shall have the power consistent with the intention of the donor to make such change(s) in the conditions governing award as the circumstances may render necessary from time to time.

## Eligibility

- The award is meant for an Indian citizen working in Agriculture & Allied Sectors Universities, and other related State and Central Government institutes / organizations operating in Andhra Pradesh and Telangana states.
- The award is to be given to a person who has made outstanding contributions in the field of rural indebtedness; understanding causative factors and ameliorative measures required with regard to farmers' suicides; and shortcomings in agricultural / rural finance in Andhra Pradesh and Telangana States.
- A deceased person will not be considered for the Award. However, the Award may be given posthumously in the event of death of the applicant / nominee after submission of application.
- A candidate, who received this award once during service, is not eligible to apply again.
- The age of the candidate should not exceed 65 years as on the date of notification.

## Procedure for submission of application

- Application should be sent in the prescribed form (attached), with all documentary evidences through proper channel.
- Application accompanied with proofs of his/her work should be sent to the Registrar, PJTS Agricultural University, Rajendranagar, Hyderabad when the award notification is announced.
- Five hard copies of application form along with PDF soft copy (CD) are required to be submitted.
- Application received after the due date will not be considered.

#### **Selection Procedure**

- The applications will be scrutinized by an internal expert committee (Faculty of PJTSAU) constituted by the university.
- The internal expert committee (Faculty of PJTSAU) will critically examine the information provided by the applicant including the significant contributions made and publications brought out.
- The recommendations of the internal expert committee will be put forth to the external committee for final decision.
- The deliberations relating to final selection will not be made public.
- The selection made by the external committee and conferred by the University will be deemed final and no protest against the selection will be entertained by the University.
- The selected awardee should give a motivational presentation on achievements of the work to the faculty and students on the University Foundation Day.
