The University hereby makes the following amendments to the PJTAU Teachers (CAS) Regulations, 2011 and PJTAU Teachers (CAS) Regulations, 2021 issued vide references 3rd, 4th and 8th cited.

However, CAS Regulations, 2011 issued vide Proc.No.2007/Ser.IV/A2/2011, Dated.24.12.2011 shall applicable up to 31.12.2024.
2	The candidate has to secure minimum marks 13/20, 14/20 and 15/20 in interview for promotion to Academic Levels 12-13A, 13A-14 and 14-15 respectively under PJTAU Teachers (CAS) Regulations, 2021	Securing minimum marks in interview for promotions in various Academic Levels under PJTAU Teachers (CAS) Regulations, 2021 shall not be mandatory. However, the candidates have to be recommended by the selection committee constituted under CAS Regulations.

3	The candidate has to secure minimum marks 13/20, 13/20 in interview for promotion to Stage – 4 and Stage – 5.	Securing minimum marks in interview for promotions in various Academic Levels under CAS shall not be mandatory. However, the candidates have to be recommended by the selection committee constituted under CAS Regulations.
